Educational Credits

Each member is responsible for making sure you are receiving the proper credit for all of your educational credit requirements, whether it be an SRI meeting, a local rule meeting or a clinic you attended. Check your profiles periodically and make sure you are receiving proper credit. If you see something wrong contact the responsible person to get it addressed ASAP. DO NOT wait until you receive your suspension letter to address the situation, it is much easier to get it corrected during the season rather than 2 months later.

OHSAA Permit Renewal For Basketball Officials

Just a reminder to the basketball officials. Your OHSAA permit renewal deadline dates are listed below in the chart. Also, your concussion certificate will be reviewed for being up to date. Your concussion certificate expires every 3 years and you cannot renew your permit without an up-to-date certificate. So as a result, some may need to complete the concussion certificate prior to your permit renewal.
